November 20th, 2020

The Village of Victor is pleased to announce the launch of Gateway Community Power, a Community Choice Aggregation (CCA) program¹ that allows us to pool local electricity demand with other Ontario County municipalities to provide low cost, **fixed- rate renewable electricity supply**. Each participating community has selected Joule Community Power² as Program Administrator. Joule works on behalf of the municipalities to secure clean energy supply at the most favorable terms and ensures there are **no contract or exit fees** for consumers.

Supply Option

There is one fixed-rate electricity supply option under our program: **100% Renewable**. You may choose to stay in the program or opt out of the program. **You will automatically be enrolled in the 100% Renewable Option unless you choose to opt out of the program before December 21st.**

- **100% Renewable Option:** 100% of your electricity supply is matched by Renewable Energy Certificates (RECs) provided by New York State renewable power plants.

Gateway Community Power Rates

Gateway Community Power has secured rates for electricity, through a competitive bidding process, that will remain stable for two years and enables you to power your home or business with 100% Renewable electricity.

- **Source Power** will be your new supplier, beginning on your first meter-read after January 1, 2021.
- The new rate will remain fixed for a 24-month period through December 31st, 2022.

* Rates do not include Gross Receipt Tax (GRT). If GRT is collected in your municipality, it will be added to your rate.

** Average RG&E electricity supply rate for residential and small commercial customers, Oct 2018-Sept 2020.

RG&E will continue to be responsible for the power lines that deliver your electricity and will continue to bill you. Please contact RG&E in the event of any service interruption.

Enrollment

If you wish to opt out of the program, please let us know by December 21st. If we do not hear from you, you will be enrolled automatically in the 100% Renewable Option, and your account information (including energy usage) will be shared with Source Power. However, you may leave the program at any time without any fee or penalty. If you choose to remain in the program, your new rate will take effect in January 1, 2021.
